# District Manager Report November 10, 2016

### **BWSR Academy**

Dustin, Jesse, and I attended BWSR Academy at the end of October. As usual, this training was very beneficial for everyone. We attended classes regarding wetlands, grants administration, buffers, and water planning, as well as others.

# **Dutch Creek Monitoring**

I met with MDH, MDA, and PCA stuff to coordinate our Dutch Creek and Fairmont Chain of Lakes monitoring in 2017. MDA is working to get a contract for us to do monitoring in the Dutch Creek watershed and PCA will be monitoring the Fairmont Lakes.

### **CRP**

Greg has been busy seeding CRP this fall. Dustin has been assisting him when time allows. A lot of the contracts are filter strips and pollinators. We have also been providing measurement services where necessary.

## Blue Earth Watershed Restoration and Protection Strategies (WRAPS) Update

We are working on a contract with PCA to do monitoring in 2017 & 2018 and subcontract with Faribault County and potentially other counties. PCA is organizing an informational meeting on November 30 to go over the watershed approach if anyone is interested in attending.
