- 1. Cover crop grant focusing on Eastern/Northeastern part of Martin County.
- 2. Dutch Creek watershed Projects.

The suggestion was made to check previous studies that were done along Dutch Creek. Possible sites for water storage upstream were identified in a BERBI report.
